Dr. Pinelopi Miniati is a Biologist who holds an undergraduate (Bachelors) and a postgraduate (Masters) degree from the University of Toledo, Ohio, USA.

In 1992 she was employed by the Greek Police as a scientific staff member, while in 2002 she was awarded her Doctor of Philosophy (Ph.D) degree in the fields of Human Genetics / Molecular Biology by the Medical School of the University of Crete / Greece.

She was a founding member of the first forensic DNA Laboratory in Greece, while she made a decisive contribution to the evolution and upgrading of this Laboratory into an autonomous Department and later into a Sub-Directorate, of which she was the first Head and Director, respectively.

From 2016 to March 2022, she held the position of the Director of the Directorate of Forensic Sciences (F.S.D.), the National Forensic Agency of the Country which serves the forensic needs not only of the Greek Police but all Law Enforcement Agencies and many Independent Authorities as well.

Both as Head of the DNA Laboratories of the Hellenic Police as well as the Director of the Hellenic Directorate of Forensic Sciences, she has actively participated in highlighting the pivotal contribution of the country's forensic laboratories to the administration of Justice.

Through specialized genetic analyses, from her aforementioned positions, she organized and handled incidents of mass disaster victim identification (Disaster Victim Identification - DVI), with characteristic examples including the HELIOS airline accident in August 2005, the extensive fires in

Peloponnese in August 2007, and most recently, the wildfire in Eastern Attica (Matí) in July 2018, highlighting the significant humanitarian aspect of returning the remains of the deceased to their relatives as quickly as possible and in the most scientifically validated way.

In March 2020, she was appointed as a representative of the Hellenic Police to the Hellenic Working Group (HGT) of the Joint Committee of Experts (JET), as well as the person responsible for signing the relevant Memorandum for cooperation between the Hellenic Police/Directorate of Criminal Investigations and of the General Staff of National Defense (G.E.ETH.A.)/Hellenic Working Group of the Joint Committee of Experts for the implementation of the project of genetic identification of Greeks Fallen in Military Operations during the Greco-Italian War 1940-41.

In April 2020, she was also appointed as a point of contact between the Greek Police and the International Committee on Missing Persons (ICMP), regarding an initiative undertaken by the said committee regarding the detection and identification of missing migrants/refugees due to migration flows in the Mediterranean.

In May 2021, she took over the Presidency (Chairperson) of the European Network of Forensic Science Institutes (ENFSI), after her two-year term as Chair Designate of the said Association. ENFSI with its 17 working subgroups covering the entire range of forensic fields and its 2 Standing Committees for Research & Development, Quality & Competence, is the main advisory body of the European Committee on Forensic issues, while representing 73 Forensic Services / Institutes from 39 member countries of the Council of Europe.

From 2003 and onwards, either as a Professor in the Police Academy -including the Continuing Education Programs for Senior and Senior Executives of the Hellenic Police -, or as speaker in a number of educational Programs organized by different Organizations and as a Lecturer in University Institutions of the Country, she has developed thematic topics in the subjects of Forensic Genetics and Forensic Sciences /Applied Criminology.

She has participated as a Speaker /Lecturer in numerous Conferences, Workshops etc both in Greece and abroad and she has been involved in a number of research projects.
